RE: Requirements of the Earnings Tax and Annual Tax Filing

The City of Springdale levies a one and a half percent (1.5%) earnings tax on all earned income. Filing of an annual tax return is required by everyone who lives in Springdale, age 19 and older, regardless of your income, whether or not any tax is due. This requirement applies to both renters and homeowners.

Tax returns are due on April 15 of the subsequent year. Also, beginning January 1, 2016, 90% of the tax liability is required to be paid by December 15. Forms, extension requests, a complete listing of taxable/non-taxable items, and other information regarding the Tax Ordinance are available upon request or at the web-site www.springdale.org.

Proper administration of the tax ordinance depends on the accuracy of our records; therefore, we appreciate your prompt completion and return of the enclosed Resident Registration.

The City of Springdale is pleased that you have chosen to reside here and we in the Tax Department want to do everything necessary to help you comply with the Tax Ordinance.
